Provisional

General License

General License

- Hold National, Regional
 - RID (all national NOT Ed:K-12), BEI, or NAD (level III & above)
- Board is working on the option of other "criteria established by Board" for the full license *(implementation at a later date)*
- Fee
 - Initial Application \$150
 - Renew \$100

Provisional General License

- Pass a Knowledge and Ethics Exam
- NOTE:
 - Cannot work in the following fields:
 - Legal
 - Education
 - Medical (the individual is accompanied with a general licensed interpreter OR a part of a formal mentorship)
 - Mental/behavioral health (the individual is accompanied with a general licensed interpreter OR a part of a formal mentorship)
 - Fee
 - Initial Application \$300 for 3 years
 - Renew \$100 for 2 years (one time)

Most asked Questions...

- Any exceptions for those working a long time or lapsed certification or close to retirement?
 - NO
- Does the General license apply to hearing and Deaf interpreters?
 - Yes
- What tests are available for Deaf interpreters?
 - CASLI CDI
 - BEI Intermediary Certification
- Does licensure apply to government settings, as well as government properties?
 Yes
- If an interpreter is freelancing with an agency or a school employee, is license still required?
 - Yes

Agencies/Businesses

Agencies/Businesses

Definition: "Agency" means any for-profit or non-profit entity that provides or arranges for sign language interpretation services in the State for any individual or other entity, including but not limited to:

(a) Consumers; (b) Government agencies; (c) Places of public accommodation; and

(d) Employers.

Responsible for providing ONLY licensed ASL interpreters in all situations

- Register with GODHH
 - Owner/business information
 - Types of interpreting services provided
 - Proof of legal existence
 - Proof of good standing with state

Agencies/Businesses (continued)

- VRI:
 - All VRI assignments (Emergency situations, Oncall, Pre-scheduled)
 - Maryland-based interpreters who work from home in other states
 - Any consumer or business who is based in Maryland
 - Does not include VRS
- Fees
 - Initial Application \$250.00
 - Renew \$200.00

Disclaimer: Agencies shall provide sign language interpreting services via video remote interpreting or on-site, in-person interpreting according to the discretion of deaf and hard of hearing individuals.

Most asked Questions...

- Who/what is considered an agency?
 - Any agency or entity that is hiring or contracting with interpreters to provide interpreting services.
- Do Sole Proprietorship, LLC, have to apply for a license?
 - ONLY if they contract out services OTHER THAN THEMSELVES
- Do organizations such as hospitals with staff interpreters need to register if they provide services?
 - Yes and No. If interpreters are considered Hospital Staff, then no. If the hospital has an interpreting department/office that operates outside of the hospital, then yes.
- What does "proof of good standing" mean?
 - Maryland has a business registry and records whether the business is in good standing or not. The Board follows the State's identification of good standing.
- What about businesses in other states?
 - If they are conducting business in the state of Maryland, they must hold an Agency License.
- Who will be holding agencies accountable?
 - ODHH, in support and partnership with the community.
- How do we know if a business is registered?
 - Check at 1st acceptance of a job and then yearly.

Speciality License: Education

Speciality License (SL): Education

- Hold a current, valid RID/NAD/BEI certification <u>OR</u> a hold a minimum score of 4.0 on EIPA.
 - EIPA Can be PSE-ASL or ASL-PSE assessment for the appropriate grade level the interpreter has been assigned to.
- Educational interpreters who hold the required EIPA score but no certification can only work in a pre-K-12 (ages 0-21) setting.
- Fee
 - Initial Application \$75
 - Renew \$50
- Renew every year
 - Earns 1 CEUs in educational interpreting and relevant topics. 0.5 of the CEUs required of PPO including deaf culture, deaf awareness, and diversity in education. They are good for 2 years

Provisional Speciality License (PSL): Education

- Obtain a passing score on the written Educational Interpreter Performance Assessment (EIPA)
- Length of Provisional license
 - 3 years with option of 2 year extension (upon applying)
- Fee
 - Initial Application \$150 for 3 years
 - Renew \$100 for 2 years (one time)

Most asked Questions...

- How is educational setting defined?
 - Educational programs or services by a public, state-funded, or nonpublic school means any setting birth through secondary education.
- How recent must the EIPA written be taken to apply for the provisional?
 - The EIPA written doesn't expire. If you have taken the test and passed you do not need to take it again.
- Are there areas in which an Educational provisional or specialty license cannot work?
 - Yes anywhere that is not an Educational setting.
- Does the Educational specialty license apply to post secondary?
 - No. Only birth through secondary.
- Why were educational requirements removed?
 - This was a huge ask from the community. The Board viewed EIPA scores as more imperative and applicable to the setting than a random educational attainment.
- Does an Educational license apply to other activities such as: Deaf adults in a school setting, Deaf parents, after-school activities, IEPs, etc.
 - Yes. Educational licensed interpreters can ONLY work in educational settings. General license interpreters can work in these settings that are not birth through secondary.

Grievance Process

Grievance Process

- No automatic suspension of license
- Cannot be annonymous
- GODHH will review to ensure all required documents are provided
- Grievance will be forwarded to the Office of Administrative Hearings (OAH)
 - OAH will review
 - The administrative judge will submit in writing the proposed findings of facts, proposed conclusions of law, and recommendations.
 - The judge will distribute the written proposed decision to all parties.

Most asked Questions...

- Is there a list of what constitutes a violation of the law with corresponding disciplinary measures?
 - The Board has asked GODHH for this information.
- Do other licensed professionals in the state have similar grievance processes?
 - The Board has asked GODHH for this information.
- How will interpreters know if they are accepting work through non-licensed businesses and what repercussions will the interpreters face?
 - Interpreters can always refer to the State Registry. Penalties will fall on the agency, NOT the interpreter.
- Isn't RID managing the consequences of abiding by the CPC? Why does Maryland need to have this process as well?
 - Yes, but RID only accepts grievances from Deaf consumers. MD law allows consumers, guardians of consumers, interpreters, and anyone overseeing services to file a grievance.
- Is OAH a diverse board to ensure that unfair bias doesn't occur?
 - The Board has asked GODHH for this information.

Internship/Practicum Students

Internship & Practicum Students

- A student who is part of a supervised internship or practicum for an accredited institution of higher education, may NOT provide sign language interpretation services in the following areas:
 - A legal setting;
 - A behavioral health setting, unless the individual is accompanied by a licensed sign language interpreter;
 - An emergency medical setting, unless the individual is accompanied by a licensed sign language interpreter;
 - A school setting, unless the individual is accompanied by an licensed Educational interpreter.

Most asked Questions...

- When will the regulations be posted on the Maryland Registrar?
 - November 25th
- When do the other specialty licenses take place?
 - The Board voted in September to move the effective date for all specialty licenses to January 1, 2026
- How do visiting interpreters work in the state?
 - Interpreters working less than 80 hours can work without license. They must self-report to ODHH. The guidelines for enforcing and monitoring interpreters working less than 80 hours are still being determined by the Board, ODHH, and the AAG offices,
- For interpreters that are doing video work, how would they know where the Deaf client is physically at during an assignment?
 - This is the for agencies to oversee since they are the ones working with the contracts. You can double check by confirming with the agency prior to accepting work.
- How will CEUs be tracked?
 - They will align with your license issuance date.
- I don't live in Maryland am I required to be licensed?
 - If you work or provide services for someone in Maryland, then you are required to be licensed.
- I interpret at a church am I required to be licensed?
 - If it is volunteer No. If you are being compensated, then yes.
- Who is keeping CASLI accountable for their results timeline?
 - Currently, CASLI has a 2 month response result rate
